Parent Participation Hours

During the school year, we ask each child's family to give at least 30 parent participation hours towards fundraising efforts, all-school tasks, and in the classroom. Families with two or more children are asked to give at least 45 hours for the school year. Details regarding the parent participation deposit can be found in our Tuition and Fees Schedule. Parents will receive a Google doc upon enrollment and will be required to keep track of their hours, updating the doc as work is completed throughout the school year. Items for the school can also be purchased for these hours and will be calculated as 1 hour for each \$10 spent, rounding up to the nearest quarter. For example a \$42 purchase would count for 4.25 hours.
